8 the authorities of such Commissions, as in ef-
9 fect before the date of the enactment of this
10 Act, with regard to over-the-counter derivatives,

12 (B) have jointly issued such final rules as
13 are necessary to implement the harmonization;

15 (2) submitted to the Congress a report detail-
16 ing—

17 (A) the matters (if any) with respect to
18 which such Commissions were able to effect
19 such harmonization;

1 (B) the matters (if any) with respect to
2 which such Commissions were unable to do so;
3 and

4 (C) the recommendations of such Commis-
5 sions regarding necessary additional legislation
6 to address the matters referred to in subpara-
7 graph (B).
