

**AMENDMENT TO COMMITTEE PRINT OF MARCH****14****OFFERED BY MS. WASSERMAN SCHULTZ OF FLOR-  
IDA AND MS. GINNY BROWN-WAITE OF FLOR-  
IDA**

At the end of the bill add the following new section:

1 **SEC. 19. FEMA PARTICIPATION IN STATE DISASTER CLAIMS**  
2 **MEDIATION PROGRAMS.**

3 The National Flood Insurance Act of 1968 is amend-  
4 ed by inserting after section 1313 (42 U.S.C. 4020) the  
5 following new section:

6 **"SEC. 1314. FEMA PARTICIPATION IN STATE DISASTER**  
7 **CLAIMS MEDIATION PROGRAMS.**

8 "(a) REQUIREMENT TO PARTICIPATE.—In the case  
9 of the occurrence of a natural catastrophe that may result  
10 in flood damage claims under the national flood insurance  
11 program, upon a request made by the insurance commis-  
12 sioner of a State (or such other official responsible for reg-  
13 ulating the business of insurance in the State) for the par-  
14 ticipation of representatives of the Director in a program  
15 sponsored by such State for nonbinding mediation of in-  
16 surance claims resulting from a natural catastrophe, the  
17 Director shall cause appropriate representatives of na-



1 tional flood insurance program to participate in such State  
2 program to expedite settlement of any flood damage  
3 claims under the national flood insurance program result-  
4 ing from such catastrophe.

5 “(b) EXTENT OF PARTICIPATION.—Participation by  
6 representatives of the Director required under subsection  
7 (a) with respect to flood damage claims resulting from a  
8 natural catastrophe shall include—

9 “(1) providing adjusters certified for purposes  
10 of the national flood insurance program who are au-  
11 thorized to settle claims against such program re-  
12 sulting from such catastrophe in amounts up to the  
13 limits of policies under such program;

14 “(2) requiring such adjusters to attend State-  
15 sponsored mediation meetings regarding flood insur-  
16 ance claims resulting from such catastrophe at times  
17 and places as may be arranged by the State;

18 “(3) participating in good-faith negotiations to-  
19 ward the settlement of such claims with policy-  
20 holders of coverage made available under the na-  
21 tional flood insurance program; and

22 “(4) finalizing the settlement of such claims on  
23 behalf of the national flood insurance program with  
24 such policyholders.



1       “(c) COORDINATION.—Adjusters representing the na-  
2 tional flood insurance program who participate pursuant  
3 to subsection (b)(1) in a State-sponsored mediation pro-  
4 gram with respect to a natural catastrophe shall at all  
5 times coordinate their activities with insurance officials of  
6 the State and representatives of insurers for the purpose  
7 of consolidating and expediting the settlement of claims  
8 under the national flood insurance program resulting from  
9 such catastrophe at the earliest possible time.”.
