

AMENDMENT TO H.R. 5443
OFFERED BY MR. NEY OF OHIO AND MS. WATERS
OF CALIFORNIA

Page 7, line 2, before the period insert “unless the payment on behalf of a family has been reduced as a result of a review under clause (iii) during the current year”.

Insert “or owner” after “agency” each place such term appears as follows: page 7, lines 9 and 17; page 9, lines 7 and 25; page 10, lines 10, 14, 18, and 19; page 11, line 8; and page 12, line 17.

Page 8, line 2, strike “clause (ii)” and insert “clause (iii)”.

Page 11, line 7, after “PHA” insert “AND OWNER”.

Page 12, strike lines 5 and 6 and insert the following:

1 “(B) EXCLUDED AMOUNTS.—Such term
2 does not include—
3 “(i) any imputed return on assets;
4 and



1 “(ii) any amounts that would be eligi-
2 ble for exclusion under section 1613(a)(7)
3 of the Social Security Act (42 U.S.C.
4 1382b(a)(7)), except that to the extent
5 that exclusion of such amounts from in-
6 come under this paragraph would result in
7 additional costs under this Act, this clause
8 shall be effective only to the extent that
9 amounts to cover such additional costs are
10 provided in advance in appropriation
11 Acts.”.

Page 13, after line 9, insert the following new sub-
paragraph:

12 “(C) HEALTH AND MEDICAL EXPENSES.—
13 In the case of any elderly or disabled family,
14 the amount, if any, by which the sum of any
15 unreimbursed health and medical care expenses
16 and reasonable attendant care and auxiliary ap-
17 paratus expenses for any person with disabil-
18 ities exceeds 10 percent of the family’s in-
19 come.”.

Strike line 19 on page 13 and all that follows
through line 2 on page 14 and insert the following new
subsection:



1 (c) HOUSING CHOICE VOUCHER PROGRAM.—Section
2 8(o) of the United States Housing Act of 1937 (42 U.S.C.
3 1437f(o)) is amended—

4 (1) in paragraph (2)—

5 (A) in subparagraph (A)—

6 (i) by striking clause (ii); and

7 (ii) by redesignating clause (iii) as
8 clause (ii); and

9 (B) in subparagraph (B), by striking “,
10 (ii), and (iii)” and inserting “, and (ii)”; and

11 (2) in paragraph (5)—

12 (A) in the paragraph heading, by striking
13 “ANNUAL REVIEW” and inserting “REVIEWS”;

14 (B) in subparagraph (A)—

15 (i) by striking “the provisions of” and
16 inserting “paragraphs (6) and (7) of sec-
17 tion 3(a) and to”; and

18 (ii) by striking “and shall be con-
19 ducted upon the initial provision of hous-
20 ing assistance for the family and thereafter
21 not less than annually”; and

22 (C) in subparagraph (B), by striking the
23 second sentence.
